## **PREPARATION INSTRUCTIONS FOR PROSTATIC ULTRASOUND WITH BIOPSY**

Take one (1) ANTIBIOTIC tablet **THE EVENING BEFORE** the procedure and one (1) ANTIBIOTIC tablet **THE MORNING OF** the procedure.

**THE REMAINING ANTIBIOTIC TABLETS PRESCRIBED ARE TO BE TAKEN FOR SEVERAL DAYS FOLLOWING THE PROCEDURE AS DIRECTED BY YOUR PHYSICIAN.**

Administer a FLEET ENEMA the night before and the morning of the procedure.  
The FLEET ENEMA may be purchased at any pharmacy.

If the procedure is being performed in the **office** you may have a light breakfast.  
If the procedure is being performed in a **hospital or facility** (other than the office) you must refrain from food and drink from midnight of the night before the procedure.

FOR ONE WEEK PRIOR TO THE PROCEDURE, YOU MUST STOP THE USE OF ASPIRIN, BABY ASPIRIN OR ASPIRIN PRODUCTS (ECOTRIN, ANACIN, ETC.), BLOOD THINNERS (AGGRENOX, PRADAXA, LOVENOX, COUMADIN, PLAVIX, ETC.) AND ANTI-INFLAMMATORY DRUGS (ADVIL, NAPROXEN, RELAFEN, CELEBREX, VIOXX, ETC.)
